#### I.Welcome and Introductions

- II. Consent Agenda
- A. **Approval of Minutes:** The vote is unanimous to approve.
- B. **Fundraisers and Trips** (Holly) SIC recently approved these three fundraisers:
  - Black Student Union carwash, planned for a Saturday in October with the East High Black Student Union to raise money for graduation stoles. Projecting \$300 in proceeds.
  - Cheer team: Mini-Cheer Camp, September 22-24, 5-6:30 p.m., with 3- to 14-year-olds. Camp participants will perform at an upcoming halftime. The cost is \$35 for participating students, with a projected profit of \$6,400 to support team costs and functions.
  - Cheer team: Chick-fil-A Night, September 28, at the City Creek store, 5-8 p.m. West will receive 20 percent of sales during the event from anyone who mentions West when making their order. Goal of \$3,000, supporting team costs and functions.

Motion to approve and promote all three: Unanimous vote.

## III. Information Items

A. **SCC meeting overview** (Katherine) – Reviewed agenda and meeting structure for potential new parent members.

#### IV. Discussion Items

- A. **Official positions**: Katherine voted to serve another year as president; Bernard as chair-elect. Katherine appoints Ami to serve as co-chair and Anna to continue as secretary.
- B. **SCC training**: Postponed until October, when new parent members are seated.
- C. **Anti-vaping PBIS plan** (Robert): House Bill 58 recently passed in response to rising vaping rates among young people. It has three parts:
  - It establishes clear policies for vaping, requiring school boards to prohibit vaping on school grounds and allowing schools to confiscate and destroy vape pens or e-cigarettes.
  - The bill adds information about the effects of vaping to school health curriculums.
  - The bill requires high schools to educate about the risks of vaping products in a
    prevention program and create a plan to address the causes of student use of
    tobacco, alcohol, e-cigarettes, and controlled substances.

In response, West has initiated the following steps:

- Confiscating and destroying seized paraphernalia, such as e-cigarettes, vaporizers, and other products.
- Adding effects of vaping to school health curriculum.
- Educating about the risks of vaping projects through PXP, clubs, advertising, classroom instruction, public service projects, student government and leadership, and other outlets. Students must be involved; it can't only be adults sending the message.
- Professional development includes a harm reduction-type model and de-escalation training.

Discussion includes questions about increasing enforcement in areas identified as high-vaping areas, reviewing bathroom layouts, and expanding parental and community education/collaborations.

D. <u>LAND Trust review</u> (current year) (Katherine): Summary of LAND Trust Proposal 2021 / 2022

**PXP** – Received late notice that proposed C Day model changes would not be approved—now working to engage other high schools and develop C Day model classes and grade-level advisory. Currently running 19 sections of PXP. \$190,000

# E. **State of the School** (Jared): Highlights:

- Enrollment at 2,734; funded at 2,809. Will seek to keep that enrollment cap. Expecting several dozen students from Afghanistan in the coming weeks.
- Sixteen national merit scholarship finalists.
- Made the transition to grade-level support teams, with a more focused view on graduation and other measures of student success.
- Held grade-level assemblies at the beginning of the year to address differing class needs.
- Successful summer school program—recovered more than 800 quarter credits, making a significant dent in the credit deficiency.
- A social worker is now assigned to West, sharing with two elementary schools. We get her three days a week.
- Added five sections of reading classes; 800-plus students are below grade level, about 90 are well below.
- Professional development focus is on academic language and literacy.
- IB numbers are 126 in 11<sup>th</sup> grade but down to 85 in 12<sup>th</sup> grade. Last year was tough on IB retention.
- Expanding integrated learning for students with disabilities. Section 1 and 2 math are being co-taught, and language arts. Both teachers help all students, so disabled students are not singled out. Data is very compelling about the benefits of integrated learning.

**COVID Update:** Numbers are relatively low comparatively, and contact tracing from the district is extremely helpful. Mask-wearing compliance has been very high. Other measures include replacing air filters more frequently, increasing fan use, and adding hand-sanitizing stations at entry-ways. The health department is very responsive to testing requests. Plans are underway for a vaccine clinic in mid-October. Motion is

made for SCC to send a letter to the Salt Lake City Council in support of extending the mayor's school masking mandate. The vote to approve the letter is unanimous.

**Late-Start Update:** Many students are arriving early at school. Breakfast is available in the cafeteria with plenty of adult supervision; other efforts are being made to accommodate the students before doors officially open at 8:20 p.m. Because of shorter travel times in the newly realigned league, most student-athletes are not missing class to get to games. Working to streamline excused absences for student-athletes when needed.

F. **Discuss Priorities for 2021/22** (Katherine): COVID protocols and safety; going forward with C-Day path; keeping an eye on reading needs.
